I am aware no alcohol or smoking is allowed. I am aware I can bring in my own food and beverage.
I am aware there is a Cancellation Policy. The Kearney Park and Recreation office needs to be notified at 308-237-4644 to cancel reservation. Office hours are Monday-Thursday from 7:30am to 5:00pm and Friday, 7:30am to 12:00pm. After hour cancellations need to be made by contacting JoHanna Burkey at 308-708-8922. No refunds issued if less than 30-day notice is given. If notice is given 30 days or more there is a \$15 cancellation fee.
I am aware that if I choose to cancel because of a chance of inclement or cold weather, I will not receive a refund or be able to reschedule. I am aware the pool staff will do everything they can to be open. If the pool has to close due to inclement weather, I understand I will receive a full refund and/or be able to transfer dates (based on availability). I also understand the pool could call as late as an hour before the rental due to ever changing weather conditions.

All requests are tentative until application is approved and returned.
